

I AM WRITING THIS LETTER IN CONNECTION WITH THE ACTION TO BE TAKEN BY STATE/UT GOVERNMENTS FOR SMOOTH TRANSITION FROM PFA ACT REGIME TO THE IMPLEMENTATION OF FOOD SAFETY AND STANDARDS ACT, 2006 WHICH INTEGRATES ALL FOOD SAFETY RELATED LEGISLATIONS(.) IN THIS CONNECTION PLEASE ALSO REFER TO MY EARLIER LETTERS ON THE SUBJECT, THE LAST ONE BEING DO. NO.1-3/FSSAI/T/2010 DATED 1ST JULY, 2011 AND THE DISCUSSION HELD WITH THE FOOD SAFETY COMMISSIONERS OF THE STATES/UTs FROM TIME TO TIME INCLUDING IN THE CENTRAL ADVISORY COMMITTEE MEETING WHO MUST HAVE BRIEFED THE STATE GOVERNMENTS(.)

AS WAS COMMUNICATED, THE IMPLEMENTATION OF FSS ACT, 2006 WILL COMMENCE W.E.F. 5TH AUGUST, 2011 AND THE PFA ACT AND OTHER ORDERS LIKE FPO, MFPO AND MMPO ETC WILL GET REPEAL WITH EFFECT FROM THAT DATE(.) REGULATIONS UNDER FOOD SAFETY AND STANDARDS ACT HAVE BEEN NOTIFIED ON 1.8.2011 AND PUT ON OUR WEBSITE (www.fssai.gov.in)(.) STATE GOVERNMENTS/UTs MAY LIKE TO MAKE AVAILABLE COPIES OF THE FSS RULES AND REGULATIONS TO THE CONCERNED OFFICERS FOR EFFECTIVE IMPLEMENTATION OF THE LAW(.)

I ALSO REQUEST FOR AN URGENT REVIEW AT YOUR LEVEL WITH REGARD TO THE ACTION TO BE TAKEN TO PUT ALL STATUTORY FUNCTIONARIES IN POSITION BEFORE 5TH AUGUST, 2011 TO ENSURE SMOOTH TRANSITION(.)
